SCHOOL FEES 2021

The proposed budget for 2021 was considered and approved at the Annual Budget Meeting held on 10 November 2020. The school fees for 2021 will be R 32 270.00 for Grade R pupils; R30 460.00 for Grades 1 – 7 pupils. The payment of these school fees is compulsory in terms of the South African Schools Act (No. 84 of 1996). In order for us to continue providing an excellent education at Manor Gardens Primary School, it is essential that parents pay school fees in full and timeously. Please note that over half the School's staff members are employed through funds generated by the payments of school fees.

A resolution was adopted at the Annual Budget Meeting held on 10 November 2020, that the Governing Body applies the South African Schools Act (No. 84 of 1996) procedure and criteria for partial or full exemption of parents from the payment of school fees if applicable and justified. Please note, however, that both parents are liable for school fees until an exemption application has been approved. A copy of the regulations relating to the exemption of school fees is available at the school. All applications will be held in strictest confidence. Should you require an exemption form please advise the Governing Body in writing.

The 2021 school fee payment commitment forms attached to this letter need to be filled in by both parents or both guardians and submitted by **Tuesday 17 November 2020**. Any payments made should be to the following account:

In the event of my failing to make timeous payment of any amount due in terms hereof, the whole outstanding balance of the agreed indebtedness shall then immediately become due and payable. Manor Gardens Primary School shall be entitled to institute legal action against me for recovery thereof and I shall be liable for the payment of all attorneys' costs including collection commission incurred by Manor Gardens Primary School in respect of such proceedings.

A. The School may hold and process by computer or otherwise any information obtained about the Parent/s as a result of their liability for school fees. The School may conduct a credit enquiry and/or credit information search about the Parent/s with a credit information bureau, persons acting as their agents and/or other credit grantors. The School may transmit details of how the Parent/s have performed in meeting their obligations in terms of their school fee obligations and share such information with other credit grantors for the purposes of making any credit risk management related decisions.

- B. If the Parent/s fail to meet their school fee obligations, the School may record the Parent/s non-performance with a credit information bureau. Any information conveyed to a credit information bureau will be available to other credit grantors and used in making credit risk management related decisions.
- C. The School may:
- Monitor the Parent/s payment behavior by researching the Parent/s record at one or more credit information bureaus;
 - Record and transmit details of how the Parent/s have performed in terms of their school fee obligations reflecting how they have conducted themselves in meeting these obligations.
 - The Parent/s acknowledge and agree that any information regarding their credit worthiness, defaults in payment to the School, and details of how they have paid their school fee obligations with the School may be disclosed to any other creditor of the applicant or school and/or to one or more credit information bureau.
- D. Should the School grant any parent any indulgence in the payment of school fees, this undertaking in no way changes the fact that the payment in full of school fees is a statutory duty and not a voluntary agreement, particularly not a credit agreement as defined in Terms of The National Credit Act No 34 of 2005.
- E. Pupil insurance is not included in the school fee. It is the parent's responsibility to purchase this insurance from a private company.
